When an invoice remains unpaid after 30 days, a late fee of 2% of the invoice total will be calculated and added to the customer's balance. Additional late fees of 2% will be calculated and added at 15 day increments thereafter. In any dispute concerning this agreement, the prevailing party will be entitled to recover its legal fees and expenses.

AFS, in supplying staffing services to **Client**, will provide all payroll and payroll taxes including statutory workers' compensation for its employees while they work under the supervision, direction and control of the **Client** in the positions described herein. **Client** must inform **AFS** of any prevailing rates set by any government agency or body prior to rate quotation.

Client certifies that **AFS** employees will be assigned to work only in the positions described herein while working under the supervision and direction of the **Client**. **Client** agrees to take all due care in protecting **AFS** employees from exposure to hazardous conditions or materials. If **Client** desires to change the work assignment of **AFS** employees, **Client** agrees to first obtain a new, signed *Service Agreement* outline the new *Description of Job Duties*. **Client** will be liable for and reimburse **AFS** for any cost directly associated to workers' compensation for an employee injured while performing any duty other than that described herein.

Client agrees not to hire an employee within 90 days after the last date of assignment to the client by **AFS**. In the event **AFS** becomes aware of such a situation, **AFS** will be entitled to a fee of \$2,500.00. **AFS** does allow the hiring of employees by the **Client** in accordance with the following terms:

- During the first 90 days of employment, **AFS** will be entitled to a fee of \$2,500.00 if the **Client** hires the employee.
- At any time subsequent to the initial 90 day period **AFS** will be entitled to a fee of \$1,250.00 if the **Client** hires the employee.

Client also agrees that the following are prohibited work environments for **AFS** employees

- Operate any unsafe equipment
- Drive any type of vehicle (including forklifts) without written approval from **AFS**
- Work below the ground (excavation) over 4 ft. deep unless properly shored

Client also agrees to use all precautions to safe guard **AFS** employees while working with or near hazardous chemicals, materials, or flammable materials. **Client** also agrees to provide proper safety equipment **OR** notify **AFS** of safety equipment needed to perform a specific job prior to *placing* **AFS** employees to a job.
